- VII. Institute an appropriate mechanism to ensure that services of teachers or other staff are not dispensed with at all without due regard to the principles of equity and fair pay. Disciplinary action or proceedings if and when warranted, shall be conducted consistent with the due respect process of law and also notified to the CEO/ZEO concerned.
- VIII. Deposit with the respect office due shall share/subscription on acccount of Games/Red cross fund in terms of the orders/instructions in force.
- IX. Furnish correct and complete information as per format provided to CEO/ZEO concerned for upgradation of District Information System of Education (DISE) and Education Management Information System (EMIS) against proper official receipt.
- X. The school authority shall apply for approval of the Managing Body within a period of one month from the date of issuance of this order.

Any deviation or default in adherence to the norms/rules laid down and the orders/instructions issued from time to time shall render the School liable for strict action which may include withdrawal of recognition, besides other penal action under law/rules.
